



REQUEST FOR AUTHORIZATION FOR REPRODUCTION/LICENSING OF LIBRARY MATERIALS

In order to protect valuable library materials, the Buffalo & Erie County Public Library (B&ECPL) permits photographing OR scanning of special materials only for authorized use approved by the B&ECPL. The B&ECPL will determine and notify the party requesting photograph or scan ("Requestor") of the charge that would apply for the requested reproductions. The Requestor must pay the cost for service specified.

The Requestor agrees and warrants that reproductions shall not be used for purposes other than the specific purpose stated below, or sold or transferred to any third party, without the prior written consent of the B&ECPL. If the Requestor requests and is approved to make a commercial use of the photographs or scanned items, or otherwise derive revenue from their use: (1) Requestor must compensate the B&ECPL in the amount stipulated by the B&ECPL (generally, either a flat payment or a percentage of revenues derived by the Requestor), and (2) Requestor shall provide an annual accounting of such revenues in a form acceptable to B&ECPL. Requestor further agrees that, if Requestor fails to disclose a commercial use of the library materials, or makes such a commercial use without entering into an agreement to compensate the B&ECPL, Requestor shall pay liquidated damages to the B&ECPL, in an amount determined by the B&ECPL to be appropriate, and at its own expense provide the B&ECPL with an accounting of all revenues derived from said commercial use and forfeit to the B&ECPL all of said revenues.

The B&ECPL retains all applicable property rights associated with the reproduced materials and the Requestor agrees that the B&ECPL also may reproduce, for its own use, the Requestor's reproduction, without charge and in the B&ECPL's absolute discretion. The B&ECPL makes no representations or warranties regarding the copyright status of the materials. It is the sole duty of the Requestor to determine copyright status and secure permissions as necessary. The Requestor agrees to indemnify and hold harmless the B&ECPL from and against any and all claims, damages, and expenses, arising from Requestor's breach of this duty.

If an item is to be published in any format (print, media, digital, Internet, etc.) and/or used for display or exhibition by the Requestor, all reproductions of the B&ECPL library materials must prominently display the following credit adjacent to the photograph or scanned item:

***"REPRODUCTION BY PERMISSION OF THE BUFFALO & ERIE COUNTY PUBLIC LIBRARY,
BUFFALO, NEW YORK"***
