Financial Report:

Treasurer Joy Insinna presented a report showing the library's current account balances. The report was received and filed for audit (W. Chapman, C. Dubel)

Library Manager's Report:

Manager Rebecca Moe reported on statistics for February and March, showing declines in Patron Count, Circulation and Computer use in February (possibly weather-related), followed by increases in all areas in March. A total of 26 programs were offered during February, March and April with excellent participation of 251 attendees. Manager Moe attended six meetings, as well as a Friends gathering in Hamburg. Ms. Moe also hosted a visit from Erie County Legislator John Bruso's office, a photo of which was posted on his Facebook page.

The ACT meeting of March 10 was well-attended, including President Sabers-Chapman and Trustees Insinna and Lord-Quinn.

The Alden-Lancaster Art Club has again requested permission to display their art works in our library during the month of October. Approved. (W.Chapman, C. Dubel) The Board discussed outside landscaping to again be done by Shani during the month of June; flowers for two pots will be donated by Association member Carrie Sabers-Graziano. The Candy Sales project report was tabled until the June meeting. The State Report was approved (J. Insinna, W. Chapman). A list of potential repairs needed was discussed, including new carpet, fresh paint, floor refinishing and new curtains/shades in the book sale room. A question was raised about possibly obtaining assistance from local Boy Scouts.
