## **President's Report:**

- The Friends: had a successful book sale and made over \$3,500.00. A date is already set for the Fall book sale- October 20-24. Two bikes will be purchased to raffle during the summer. The candy bars selling well, typically bring in about \$300 per month.
- ACT meeting: Mike and Judy attended the ACT meeting in Hamburg. Ken Stone reviewed finances. Trustees are covered by an umbrella policy from Central. The new Hamburg library is wonderful, very colorful and creative, large space for computer use.
