UNFINISHED BUSINESS:

- Town of Tonawanda Public Library Initiatives: Town will put out a bid request for carpeting at the Kenilworth Library (excluding the Community Room which is being carpeted with funds from the Friends). Cost of carpeting will be through the Greenhaven account.
- Amend Treasurer Duties: Discussion re: proposal to amend Article IV Section 4 of by-laws to read as: The treasurer shall make disbursements from private funds of the library with the approval of the Board (and shall prepare monthly financial reports consisting of actual revenues and expenditures compared to budgeted amounts and distribute this report to the Board.) This amendment will be voted on at the next meeting.

NEW BUSINESS:

- Officers for 2017: Sheila Ginnane, Laura Glass and Kathy Kanaley will present a slate at January 2017 meeting.
- Premise Communications (PremCom) Telephone System: Director Darden is working with telephone system used by Town to determine cost and benefits of securing the same system for the Library.
- Suspension of Library Privileges Appeals Process: Motion made by Annette Della Posta to approve the Suspension of Library Appeals Process. Motion seconded by Eileen Crawford and passed.
