In 2018, the Buffalo & Erie County Public Libraries, representing 37 libraries and the *Library on Wheels* bookmobile, circulated over 6.51 million materials. The combined door count was 2.86 million. Last year, for every \$1 received from Erie County taxpayer funding, \$4.80 went back to the community in library services and programs. Buffalo & Erie County Public Libraries have over three million materials available for borrowing including books, eBooks, DVDs, CDs, downloadable music and more.
