On March 14, the White House signed an [executive order](#), signaling its intent to eliminate the Institute of Museum and Library Services. Organizations nationally, and locally, have expressed their disappointment with this move – which would claw back key funding for many libraries. Thankfully, through the generosity of Erie County and the value we all place upon our libraries, the Buffalo & Erie County Public Library will be shielded from existential threat. But we are not completely immune.

How does this decision trickle down to Buffalo and Erie County?

- Since 1996, the Institute of Museum and Library Services, and its Grants to States Program, has provided up to \$8.1 million annually to support the New York State Library – including a majority of its positions.
- That State Library is responsible for distributing over \$100 million in state operating aid to support libraries of all types, as well as \$45 million in construction aid. **The loss of that funding, reduction in funding, or delays in receipt would be devastating to our communities - and the excellence of our public libraries.** Every year, we rely on construction aid to help with building renovations, upgrades, and accessibility improvements for you, our patrons.
