A few programming highlights planned in early 2020 include "A to Z Come Read with Me!" the annual Winter Reading initiative for children, teens, adults and classrooms, running now through March 13. "Take Your Child to the Library Day" on Saturday, February 1, and the Census 2020, *Get Counted @ Your Library* campaign that includes job recruitment promoting free use of public computer stations and library WiFi for census input.

In 2019, the Buffalo & Erie County Public Libraries, representing 37 libraries and the *Library on Wheels* bookmobile, circulated over 6.63 million materials. The combined door count was 2.8 million. Buffalo & Erie County Public Libraries have over three million materials available for borrowing including books, eBooks, DVDs, CDs, downloadable music and more.
