All Buffalo & Erie County Public Libraries are open to the public with mask wearing and social distancing protocols in place. Programming highlights in 2021 include the new "*B is for Book: Children's Stories through the Centuries*" exhibit at the downtown Central Library, the virtual Winter Reading Challenge for children, teens, adults and classrooms, running now through March 5, and a virtual winter campout-themed "Take Your Child to the Library Day" on Saturday, February 6. The Library hosts the weekly virtual "IMAGINE Buffalo" lecture series on Tuesdays and "Lunchtime Learning" programs on topics ranging from Black History Month to Women's History Month, budgeting and financial wellness, researching family history and more.

In 2020, despite being closed for several months due to the COVID-19 pandemic, Buffalo & Erie County Public Libraries, representing 37 libraries and the *Library on Wheels* bookmobile, circulated over 4.43 million materials including over 1 million eBooks and eAudioBooks. There were 6.5 million website visits and more than 1.25 million in-library visits. The Library System has over three million materials available for borrowing including books, eBooks, DVDs, CDs, downloadable music and more.
