UNFINISHED (OLD) BUSINESS

After discussion, the board approved the use of \$600 in funds given to the library from the Western New York Library Resource Council for purchase of 25 non-fiction books related to health topics. NEW BUSINESS

BECPL Contract

The 2020 Buffalo and Erie County Public Library Contract was approved by resolution following a discussion. Trustee Rizzuto moved and Trustee Becker seconded the motion. The resolution was passed by roll call vote, 5-0.

Sidewalk and Cement Work

The sidewalks and a part of the foundation on the corner outside the meeting room are starting to crumble. Director Heintz reported that it is unlikely that we would be able to receive a NYS Construction Grant for 2020-2023 for the project. She is in the process of getting bids and looking for sources of funding.

Future Library Board meeting dates and venue

There was discussion about when it might be feasible to hold board meetings in the meeting room, rather than via Zoom.

Updates to Reopening Plan

Director Heintz informed the board that Stages 3 and 4 of the plan have been scaled back a little for now. The governor lifted staffing restrictions, but the BECPL requested that we scale back more on hours due to budgetary problems. Therefore, we are now basically at Stage 2 of the plan.

Trustee Banaszak moved, and Trustee Becker seconded a motion to adjourn the meeting. The meeting was adjourned by a roll call vote of 5-0 at 5:48 pm.

Correspondence

- 6/18/20: an email from the NYS Department of Library Development informed us
 of a new law passed allowing projects funded by the FY 2017/2018 State Budget
 (our current construction project) an additional twelve month extension to
 complete all project activities.
- 6/24/20: An email from Mary Jean Jakubowski dated 6/24/20 was received by all the contract library directors. It explains budgetary and scheduling concerns with examples of how scheduling should look and a request to scale back more on hours. Said email was forwarded to the board on 6/26/20. After discussion with our Board President and members of Library Administration, the decision was made to zero out hours for Sr. Pages, Pages, and our one regularly scheduled PT Librarian until August 29th, unless the situation changes. All affected employees are still in our employment and still on payroll. Unemployment filing information was given to all affected. Before we reopened, two Pages had resigned as well. Taking all of this into account, the end of year payroll budget projection ends in \$21,209.42. The system is asking for these actions to be taken as they anticipate possible mid-year budget cuts and they have to go before the Erie County Legislature very soon.

Director's Report

Library improvement projects:

 - Bids for the security camera and door projects have been awarded. Materials are being ordered and projects should start soon.

Reopening update:

- As of June 15th, the library reopened to the public with limited services and limited hours (30 instead of the normal 47.5 in the summer).

Old (Unfinished) Business

 The \$600 in funds given to the library from the WNY Library Resource Council to use for health literacy initiatives in the library has been earmarked to be used to purchase 25 books for the children's non-fiction section. At this point, Podlucky Cement has the contract with the Town and will be approached for an appointment to get estimates.
