Financial Update

Ann Marie Newbury gave the Treasurer's Report noting that we are in between statements for the community fund so she will go over it during the September meeting. M and T Bank has dropped the rates to 2.75% with an expiration date of 10/31/2028. The Treasurer's Report showed that Vouchers 1101-1107 were approved for operating funds and Vouchers 551-552 were approved for local funds. A payment was made for a fire service call on a request from the Central Library to update the security system. Doug McFarland moved to approve the report seconded by Rob Kubiak. Motion carried.

Librarian's Report

Tom Carloni gave the Librarian's Report noting that the circulation numbers are down a little bit due to door counter inconsistencies between years. A discussion about the successful programming the library has been having for the start of summer, including the Summer Reading Kickoff and Take & Make Crafts. Christine Tempestoso brought up an idea of a story walk around the library grounds. A discussion regarding new plants and shrubs to brighten up the outside of the building including reaching out to the OP Garden club for a collaboration.

Friends of the Library Report

Rob Kubiak attended the June 25 meeting, his first time as a liaison. He noted that it was an informational meeting and is looking forward to getting to know the group better. The Friends are planning a special sale in November 2025 and are making baskets for the Taste of Orchard Park.

OPCS Liaison

Christine Tempestoso reported that summer school is at Eggert Elementary. Windom and Ellicott will be hosting author and illustrator, Alex Willian in April 2026. South Davis and Eggert will be hosting author and illustrator Jarrett Lerner in Spring 2026. The 2025-2026 school year begins Wednesday, September 4, 2025.
